### RURAL ADDRESS ASSIGNMENT

Rural address assignments will follow Chapter 217 of the Code of Green Lake County relating to Road Names and Building Numbers.

#### GENERAL INFORMATION:

1. The landowner or their designee may obtain a rural address assignment application from the County Real Property Lister located in the County Treasurer's Office or from the local Town Board Designee.
2. Once completed, forward the form to the appropriate local Town Board Designee (listed on reverse) with a copy of an aerial image of your parcel with structure location marked. Visit the Green Lake County website at [www.co.green-lake.wi.us](http://www.co.green-lake.wi.us) to obtain an aerial image.
3. The local Town Board Designee forwards the completed rural address assignment application with aerial image to the County Real Property Lister to review all information.
4. The County Land Use Planning and Zoning Department, GIS Office will assign an address within 5 business days and return the rural address assignment form with the assigned address to the Real Property Lister.
5. The Real Property Lister will distribute copies of the completed rural address assignment form along with a letter to:
  - a) Landowner
  - b) Town Board
  - c) Sign manufacturer
6. Once received back from the Real Property Lister, the landowner will need to take a copy of the address assignment form to their local post office if planning to receive mail at the newly assigned address.

#### INFORMATION NEEDED TO ASSIGN AN ADDRESS:

- 1) Completed Rural Address Application with signatures.
- 2) A marked up aerial image from the GIS map located on the County website at [www.co.green-lake.wi.us](http://www.co.green-lake.wi.us) .
